TERMS AND CONDITIONS

Promoter	CUB Pty Ltd (ABN 76 004 056 106), 58 Queens Bridge Street, Southbank VIC 3006.
Who can enter?	Only Australian residents who: (a) are aged 18 or over; and (b) can take the prize in Melbourne between 29/09/2023 and 01/10/2023 (inclusive).
Who can't enter?	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition.
Competition Period	12.01am (AEST) 31/07/2023 to 11.59pm (AEST) 08/09/2023.
Venue	The competition will run in the following liquor licenced venues in Victoria: 1. The Leighoak Hotel, Oakleigh. 2. Moonee Valley Legends, Moonee Ponds. 3. The Junction Club, Moonee Ponds.
Qualifying Purchase	2 schooners or 2 pints (in one transaction, to share with a friend) of Carlton Draught.
Entry instructions	To enter, you must, during the Venue's Competition Period: (a) make a Qualifying Purchase from the Venue; (a) receive an entry form from that Venue (subject to stocks remaining); and (b) fully complete the entry form and put it in the entry box at that Venue.

- 20 Subject to the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury (including allergies, skin conditions or other reactions, as relevant), illness or death suffered in connection with this competition or any prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
- 21 Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, damage to or delay in delivery of prize/s, or for any damage that occurs to displayed prize/s (where relevant). Unless otherwise specified, prize/s will only be delivered to addresses in Australia.
