

COOK BEAUMONT – AFL GRAND FINAL PROMOTION

TERMS AND CONDITIONS	
Promoter	CUB Pty Ltd (ABN 76 004 056 106), 58 Queens Bridge Street, Southbank VIC 3006.
Who can enter?	Only Australian residents who: (a) are aged 18 or over (b) can take the prize in Melbourne between 30/09/2023 and 01/10/2023 (inclusive).
Who can't enter?	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition
Competition Period	12.01am (AEST) 17/07/2023 to 11.59pm (AEST) 08/09/2023.
Venue	The competition will run in participating Cook Beaumont liquor licensed venues in Victoria (8 venues in metro and 6 venues in regional) where advertising is displayed.
Qualifying Purchase	Any Carlton Draught, Pepsi or Schweppes product.
Entry instructions	To enter, you must, during the Venue's Competition Period: (a) make a Qualifying Purchase from the Venue; (b) receive a loyalty card from that Venue, and the corresponding number of stamps to the qualifying purchase (subject to stocks remaining); (c) make a further Qualifying Purchase (subject to daily entry limits) from the Venue to receive a stamp (1 stamp per Qualifying Purchase); (d) once you have 4 stamps on your loyalty card, present the card to a Venue staff member to receive an entry form (subject to stocks remaining); and (e) fully complete the entry form and put it in the entry box at that Venue to go into that Venue's weekly minor prize draw. For the avoidance of doubt, each loyalty card is specific to a Venue and can only be used at that Venue.
How many winners will there be and how will they be chosen? Minor prize draws in Venue The minor prize draws for both regional and metro Venues will be held weekly (on a Friday, commencing from 21/07/2023) at each Venue at 6.00pm (AEST). In each minor prize draw, the first valid entry randomly drawn from all entries received up to the draw date will win the minor prize. Major prize draw – regional Venues There will be 6 major prize draws (1 for each regional Venue). After the last weekly minor prize draw has occurred in a regional Venue, a major prize draw will be conducted in each Venue at 4.00pm (AEST) on 10/09/2023. In each draw, the first valid entry randomly drawn from all entries received during the Competition Period (including any minor prize winning entries) will win the regional major prize for that regional Venue. Major prize draw – metro Venues After the last weekly minor prize draw has occurred in a metro Venue, all entries from each metro Venue (including minor prize winning entries) will then be forwarded to the major draw location and combined. Entry

- 2 Your entry must be received during the Competition Period and will be deemed to be received only when received by the Promoter. Where relevant, submitted entry forms are the Promoter's property. If you return a Qualifying Purchase your entry may be deemed invalid at the Promoter's discretion (unless the product is defective). Prizes

- 17 If this competition cannot run as planned for any reason beyond the Promoter's control, for example due to software, hardware or communications issues, unauthorised intervention, tampering, fraud or technical failure, government directives, a pandemic, public health orders and the like, the Promoter may end, change, suspend or cancel the competition or disqualify affected entries/entrants, subject to any necessary approval by the state/territory gaming authorities.
- 18 The Promoter is not responsible for any tax implications arising from you winning a prize. You should seek independent financial advice. - 20 Subject to the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury (including allergies, skin conditions or other reactions, as relevant), illness or death suffered in connection with this competition or any prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
- 21 Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, damage to or delay in delivery of prize/s, or for any damage that occurs to displayed prize/s (where relevant). Unless otherwise specified, prize/s will only be delivered to addresses in Australia.
- 22 This competition is in no way sponsored, endorsed or administered by, or associated with any social media platform, including Facebook, Instagram and Twitter. You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.
