Terms and Conditions

Who can enter?	Only Victoria, South Australia, Western Australia, Tasmania, Queensland and Australian Capital Territory residents who are aged 18 or over.
Who can't enter?	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition.
Competition Period	12.01am AEST on 15/04/2024 to 11.59pm AEST on 15/05/2024, or until prizes are exhausted (whichever is earlier).

Entry instructions	To enter, you must, during the Competition Period: (a) visit the Website, locate the entry page and fill out and submit the online entry form, including by uploading an image of your ex's belongings and select which scenario you would like to 'hex your ex' to, and providing all other requested information. The Promoter is not responsible if your mobile device/desktop is not sufficiently capable for the purpose of submitting an entry, including having the requisite photograph capability. For avoidance of doubt, ex's of entrants will not be hexed as part of this competition, and this language is for entertainment purposes only.
How many winners will there be and how will they be chosen?	There will be up to 150 winners determined in respect of this competition. Winners will be determined on a 'first-in wins' basis, where the first 150 valid entries received during the Competition Period will each win a prize.

Entry

- 2 Your entry must be received during the Competition Period and will be deemed to be received only when received by the Promoter. If online or SMS entry is available, you will receive a return message confirming your entry. The Promoter is not liable for any problems with communications networks outside its reasonable control. The Promoter may, at any time, require you to produce documentation to establish to the Promoter's reasonable satisfaction the validity of your entries (including documentation establishing your identity, age, place of residence and place of employment).  - (b) engage in any conduct that may jeopardise the fair and proper conduct of the competition;

 - (e) breach any law; or

- 21 Without limiting the previous paragraphs, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, damage to or delay in delivery of prize/s, or for any damage that occurs to displayed prize/s (where relevant), due to circumstances beyond the Promoter's reasonable control.
