Terms and Conditions

Who can enter?	Only New South Wales residents who are aged 18 or over.
Who can't enter?	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition.
Competition Period	12.01am AEST on 30/04/2024 to 11.59pm AEST on 07/05/2024 or until prizes are exhausted (whichever is earlier).

Entry instructions	To enter, you must, during the Competition Period: (a) visit the Website, locate the entry page and fill out and submit the online entry form, including by uploading an image of your ex's belongings and select which scenario you would like to 'hex your ex' to and providing all other requested information. The Promoter is not responsible if your mobile device/desktop is not sufficiently capable for the purpose of submitting an entry, including having the requisite photograph capability. For avoidance of doubts, ex's of entrants will not be hexed as part of this competition, and this language is for entertainment purposes only.
How many winners will there be and how will they be chosen?	There will be up to 18 winners determined in respect of this competition. Winners will be determined on a 'first-in wins' basis, where the first 18 valid entries received during the Competition Period will each win a prize.
What can I win?	There are up to 18 prizes available. Each prize is a 4 pack of Vodka Cruiser Cola valued at \$23. The Promoter must follow the NSW regulations that state only a maximum of 20L of alcohol can be awarded in an entire promotion.
Total prize pool	The total prize pool is up to \$414.

How and when will the winner/s be informed?	Winners will be notified in writing within five business days of determination with details on how to verify their entry and claim their prize. Entry
