Who can enter?	Only Australian residents who are aged 18 or over.
Who can't enter?	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition.

Entry instructions	To enter, you must, during the Competition Period: (a) visit the Website, locate the entry page and fill out and submit the online entry form, including providing all other requested information to automatically receive 1 entry into the draw. How many winners will there be and how will they be chosen?	There will be 10 winners determined in respect of this competition. There will be 1 draw conducted. The draw will be held at 12pm (AEST) on 22/09/2023 at Gadens, Level 13, 447 Collins Street, Melbourne, VIC 3000. Entry

General

- 23 Subject to the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury (including allergies, skin conditions or other reactions, as relevant), illness or death suffered in connection with this competition or any prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
- 24 Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, damage to or delay in delivery of prize/s, or for any damage that occurs to displayed prize/s (where relevant).
